OLD TIME TALKS

Mrs. Millie Blizzard, the subject of this sketch, was born on the 18th day of January, 1788, near Cambridge, Maryland. Her father's name was Job Willougby and her mother's maiden name was Mary Mills. They were quiet and industrious settlers, devoting their time to farming mostly, on a small piece of land, about two miles from Cambridge. Mr. Levin Willoughby, an old pioneer of Madison County, was a son of this couple and a brother of Mrs. Blizzard's. The country around her birth-place was wild and mountainous and a great deal of trouble and fear were caused by the frequent depredations and stealing of the hostile indians. On one occasion a number of red skins while on their periodical raid stole away a white woman, an aunt of Mrs. Blizzard's, and placing a gag over her mouth hid her under a load of furs and skins until they had passed out of the reach of the settlers. She was compelled to remain a prisoner among them for nearly three years, w hen she finally made her escape and returned to her friends in Virginia. During that time she became so accustomed to their uncivilized manners that it was some time before she could be induced to wear sufficent clothing.

When she was about eleven years of age, or in December, 1799, the sad news of the death of Gen. George Washington was spread over the country. Congress being convened at Philadelphia, adopted joint resolutions recommending the people of the Union, to assemble in their respective localities "to testify their grief by suitable eulogies, orations and discourses, or by public prayer." and to wear crape on their left arms for thirty days. Thus the great General's funeral sermons were preached over the Union on one and the same day. She attended the services held in the Church of England in Cambridge on that day. The place of worship was draped in deep mourning, Long black streamers pending from the ceiling from altar to vestibule. The Order of Free Masons being desirous of showing their respect for their departed brother, preformed their peculiar ceremonies by forming in two files at the door, facing each other, and crossing swords, slowly passing through the steeled arch in front of the church, where with their regalia, cross keys, open Bible, etd., they presented an impressive spectacle to the eye, never to be forgotten.

Many incidents are related by the old lady, showing the extra-ordinary clearness of her memory of events occurring at that early age. After the death of her parents she emigrated to Ross County, Ohio, in 1814, accopmanied by her brother Levin Willoughby, now dead, her sisters and several others, seeking homes and fortunes. They traveled the whole distance in wagons, experienced many trials and hardships, reaching their destination in five weeks from the time of starting. They settled on the old Governor Worthington farm, five miles from Chillicothe, which place and Columbus at that time were the only trading posts in this section of Ohio. They lived in a small log cabin as comfortably as possible, and did some farming.

THE LATE ABRAHAM SIMPSON'S WILL

The will of the late Abraham Simpson, of Deercreek township, was admitted to probate last Monday. The will is dated Aug. 17, 1882, and bequeaths: Item 1: To his beloved wife all his household goods. beds and bedding, books, pictures, etc.; also his gray horse, side saddle, buggy, harness, etc, and all the land he owns on the north side of the West Jefferson, South Charleston and road, in Deercreek township, she to hold said land during her lifetime; also one cow and two stalls in his new stable on the south side of the road, with privilege of having corn and other feed for her stock; also as many hogs as she shall, within ten days after his decease, select. Item 2: To his son, Aurelius Simpson, he gives his . silver watch, received from his fathers estate. Item 3: To his son Lafayette Simpson, he gives his walking cane, with name theron. Item 4: To his daughter, Sarah A. Withrow, he gives his watch seal and steel watch chain. Item 5: Directs that his land lying south of said road be rented by his executor and that one-half of the rent money be paid to his wife, the other half to go toward paying taxes on all the lands, making needed improvements, and if any residue is left that is to be divided between his sons and daughters; and if his wife shall depart this life before the present owner of the land lying north and adjoining his land, towit: Thomas Bales, shall die, then he directs that his executor shall continue to rent the lands (including also the land on the north side of the road) during the lifetime of said Bales, and after paying taxes, repairs, etc., to pay the money to his children. Item 6: Directs that after the death of his wife and said Bales that his real estate be sold at private or public sale and the proceeds divided among his children; Fidelia Hornbeck, Lafayette Simpson, Sarah A. Withrow, Elizabeth F. Defenbaugh and Aurelius Simpson- one fifth to each-or, if any shall die leaving no lawful issue, then his or her share shall go to the others. Item 7. Directs the sale of his personal property, not otherwise willed, and collection of all notes, accounts, etc., and out of the same to pay just debts, funeral expenses, erect a sutiable tombstone, etc., the balance, if any, to be divided among his sons and daughters. Item 8: Nominates and appoints his son, Lafayette Simpson, executorof the estate.

Ex-Probate Judge Oliver P. Crabbe, aged 83, was born on Big Darby and spent most of his life in Madison County. Excepting his eyesight he enjoys fair health. He served 18 years as probate judge and also three terms as county recorder and suditor.

Mrs. Helena Bidenbach, aged 84, was born in Rheinish, Bavaria, Feb. 13, 1825, and has lived in London for 50 years. She is the widow of George Bidenbach, and lives with her son-in-law, Charles Anderson, the hardware dealer, on East Fifth street. Quite strong and hearty, she enjoys her household duties.

William Crawford Minter, aged 93, was born near Cynthiana, Ky., March 2, 1826. When a lad of 13 years he came to Lafayette, this county, with his parents, who settled on a farm. He enjoys good health and makes his home with his daughter, Mrs. George Van Wagener, London. He has a son, William, at Springfield.

Mrs. Minerva A. Acton, aged 82, was born May 22, 1827, in London, and has lived here all her life, with the exception of three years, which she spent in West Jefferson. She lives in the same block in which she was born. Mrs. Acton is bright and active and interested in all good service, in helping the church of her choice and doing many kindly deeds.

John Gilliland was born in Ohio, July 25, 1812, and his wife (Miss Almira Waldo) in Franklin county, May 5, 1819. They were married in the Opposum Run neighborhood in 1836. Mr. Gillialand taught school in early life. He came to London, 34 years ago and embarked in the shoe business in 1882. This couple enjoy good health. Mrs. Gilliland being particularly spry.

E. J. Gould, of London, aged 84, was born in Caldwell, N. J., on Jan. 6, 1815, and when a mere boy drove, with his parents, the entire distance by wagon from New Jersey to London, and a few years later he went in partnership with his brother William in the lumber business, and retained an interest until the planing mill burned in 1899. From 1875 to 1879 he also conducted large sawmills at Port Oxford, Ore., and while there he was amember of the state legislature. Since that time he has employed his time in the greenhouse business, assisted by his sons, Theo., Donald and Cecil.

George Ronemous, aged 85, was born in Martinburg, W. Va., Feb. 12, 1814. He was married at Plattsburg, O., and later came to London, where he has been for 44 years actively engaged in the tailoring business, 18 years of which have been spent in the Finley block. He is in fair health and makes his daily trips to his place of business, when the weather permits. He is the father of 10 children, eight of whom are living.

Aunt Mary Weber, of London, aged 82, was born in Wilburburg, Germany, Aug. 1, 1827. She arrived in New York City about 60 years ago on a sailing vessel, it taking 73 days to make the voyage. A few years later she was married in Columbus to Peter Weber, who conducted the old Weber house, now known as the Mollissey grocery, and moved to London, where she has resided about 56 years. She is the mother of six children, of whom five are living, two residing in London, Mrs. Barbara Peirce and Mrs. Cass Speasmaker, where Aunt Mary makes her home. here is no person in London better liked and more respected than the good-hearted Aunt Mary Weber. At present she is in poor health.
