

New cases

Dollie R. Wilson, Admr., vs. Stephen Phifer et. al.

Note secured by mortgage on 27 acres of land near London, known as a fruit and vegetable garden, also tenements and hereditaments. Amount claimed due \$5,000 with interest from April 1, 1899, and foreclosure of premises. For another cause of action, plaintiff claims that the premises on Oct. 4, 1898, leased said premises to Herbert Adams for three years. As plaintiff was not a party to said lease, she asks that said contract be declared void and the said lease be cancelled. B. H. Lewis attorney's plaintiff.

Ameline W. Richmond vs. Caroline M. Boyd et. al.

Petition for partition of estate of Nancy Wilson, consisting of 426 acres in Somerford township. The tenants in common are Caroline M. Boyd, Mary A. Stutson, Nancy H. Williamson and Emeline W. Richmond, each 1-6th; to Chas. A. Wilson, Walter A. Wilson, Lamar P. Wilson, Alice C. Wilson and Laura B. Johnston, each 1-30th; to Albert Wilson, Napoleon B. Wilson, Ada Watts and Mary Johnson, each 1-24th. Plaintiff also asks that N. F. Williamson, in whose possession the land has been since her mother's death, be required to account for rents, profits, etc. McCloud & Converse and Lincoln & Lincoln attorneys for plaintiff.

EARLY DAYS IN MADISON COUNTY CONTINUED.....

Feb. 9, 1881

MADISON COUNTY DEMOCRAT

March 19, 1811. Bazel Hunt paid \$1 as judge of Stokes township.

Wm. Noteman was paid \$1 50 as constable of Court of Common Pleas.

In June, 1811, John Arbuckle was paid \$2 for crying the sale of lots in the town of Madison.

The first Monday in August, L. H. Post was appointed county treasurer, and was ordered to be at the house of Thomas Gwynne and enter bail.

John Davis was paid \$1 50 for guarding the prisoner Usual Osburn, who was confined in jail.

John Arbuckle was paid \$3 00 for attending a called Court as associate Judge of Madison county. David Mitchell, Esq., as same. Jacob Johnson was paid \$1 30 for 10 meals' victuals for prisoner in jail.

October 2d, 1811. Ordered that there be allowed to Curtis Ballard the sum of \$2 for crying the sale of the Court House and the jail in the town of London, by order of the Board.

Uriah Urmbles was paid \$13 33 and \$61 66 as services in building the new Court House.

The jurors in 1811 were Curtis Ballard, Richard Brock, James Pringle, Philip Crider, Calvin Carey, Jr., James Withrow, John Kent, Daniel Brown, Peter Helphenstine, Samuel Timmons, John Shields, Charles Atkinson and Philip Lewis.

Ralph Osborn was paid \$33 30 for services as Prosecuting Attorney.

December 2d, 1811, Wm. Sutton was paid \$9 25 for making chairs and tables for the Court, and Jonathan Mitchell 1 for hauling same to the house where court was held.

Wednesday, February 16, 1881

March 16th, 1812. The Commissioners met and examined the duplicate and forwarded the same to Auditor of State.

The Grand Jury for March, 1812, were: Furgues Grimes, Jonathan Minshall, David Foster, Samuel Blair, Francis Grant, Andrew Noteman, James Mark, John McDonald, David Gaston, Hugh McGarney, Elias Langham, James Whiteside and David Bradley.

June 8, 1812. Levi H. Post was allowed the sum of \$26 75 for his services as County Treasurer for the year of 1811. The total amount of money raised for county purposes by the Treasurer up to this time was \$1,844.25. Philip Lewis was appointed Clerk of the Board for the ensuing year. Patrick McLene was appointed Road Commissioner.

Jurors for July term of Court, 1812: P. Cryder, Richard Brock, Elias Langham, Jere Minor, Leonard Alkire, Wm. Cantick, Joseph Ward, James Douglass, James Kent, Jonathan Burgess, Garrison Waddle, John Phifer, James Curry.

December 19, 1812. The Commissioners viewed the old State road from Franklinton to Springfield. Jesse Dungan paid \$2 for services as judge of election; John Smith \$1 as same in Pleasant. (there is some doubt as to who this John was.)

March 5, 1813. Uriah Humble finished the Court House. Among the jurors of March term of Court, 1813, were George Prugh, John Timmons and Robert Smith.

Samuel Robinson was paid \$2 for delivering the poll book of Darby township.

John Ross and Wm. Noteman were paid \$2 for guarding a prisoner named Sprague.

June 8, 1813. Paid to Robert Hume \$68 67, balance due him for services in opening the annual collection for the year, 1813, recording the plat of the county of Madison, receiving returns of six Justices of the Peace, receiving commissions and books for use of Court of Common Pleas.

Peter Vandiventer, John Scott, John Adair, Jonah Bradley and Burton Blizzard were on the Grand Jury, March term, 1814.

Joseph Russell, Moses Cooper, Samuel Cox, Stephen Cox, and James Collins were paid for boarding a prisoner, George Miller.

Joseph Russell was paid \$2 for use of his house by commissioners.

December 6, 1814. Ordered the sum of 50 to John Mufin for building a bridge over Oak Run.

Wm. Turner paid \$18 for jointing and topping out the Court House chimney; same paid 50 cents for painting same.

Wm. McCormack paid \$2 25 for three days as viewer of the road from the N. W. corner of Pickaway Co.

The Board received the Court House on Jan. 7, 1815, and paid John Warner \$17 for chalking and daubing the same.

"Black John" was paid \$1 75 for cleaning out Court House.

Ordered that Jas. McDonald, Robert Alkire, Henry Judy, James Whiteside, Wm McNutly, John G. Gwynne, Jno. Mullin, David Harness, Thomas McCafferty, John Mozzer, Dr Simon Steer and Peter Paugh be paid 50 cents each for services as petit jurors in case where State failed.

Philip Lewis paid for services as Sheriff. Issued a certificate to John Williams on the road running from John Hunter's, through London, in the direction of Xenia.

John Smith paid \$34 50 for services as Road Commissioner on the road "leading from London, past Springer Spring towards Chillicothe."

Jonathan Alder was a Grand Jurymen in the October Court.

Five dollars was donated for a seal and standard measure.

John Murfin was allowed to build a bridge on the south of London, to his stable.

DISTRESSING ACCIDENT

Death of Tim. Chamberlain by Drowning

When we bade adieu to our office boy Tim Chamberlain, on the departure of the Eagle Guards from our midst, we little thought we should so soon be called on to record his untimely death, yet such is our sorrowful duty. Without any previous notice being received, Geo. Chamberlain, brother of Timothy, arrived here on the 2.25 train on Sunday morning last, with the corpse of the latter, who was drowned in the Kanawha river, near Parkersburg, Va., on Friday last.

THE LATE MRS. MARY D. SAUNDERS

Mary D. Saunders, the subject of this obituary, was born in Bedford county, Va., March 19, 1797, and died on the 3d day of the present month, making her 96 years, 4 months and 15 days old. Her parents were George and Mary Asbury. Her father served heroically through the entire revolutionary war, proving his zeal by shedding his blood in the battles of Brandywine and the Cowpens. Her brother, Henry, remembered by many here, also served through the war of 1812, and was among the first to receive a wound in that war. Her son Gamaliel, enlisted in the 26th Ohio regiment in the late rebellion and served until his death, which was caused by wounds received in the battle of Chicamauga. She married Samuel H. Saunders in Virginia in 1824, and removed to Ohio in '31 or '32 and settled on what is known as the Asbury or Mitchell farm, four miles west of London. Since that time all but a few years of her life which was spent in Springfield and Logan county was spent in this neighborhood.

She was the mother of four children, Paulina, Gamaliel, Martha and Semphronous. Gamaliel and Martha have both died, while the other two survive her. Her husband Samuel H. Saunders, died at Delaware nearly 60 years ago. She was the last survivor of her father's family of seven children four of whom lived from 88 to 100 years old. She was an earnest Methodist and a member of that church of 84 years. She was very proud of having heard Bishop Frank Asbury and Lorenzo Dow preach.

She was converted, sanctified and joined the M.E. church in her youth, and has been a consistent member ever since. Much could be said of her mother, grandmother and aunts, who joined the M.E. church, under John Wesley's and Daniel Asbury's ministry. Daniel Asbury being her uncle. She was a great grand daughter of Bartholomew DuPugh, who gained amnesty for the Christians against the Pope of Rome.
